Election of Chairperson

Dr. Angela Green nominated Gregory Faulkner as Chairperson. Marjorie Dienstag seconded the nomination. Panel Member Lee nominated Thomas Sheppard as Chairperson. Panel Member Izquierdo seconded the nomination. Gregory Faulkner was elected Chairperson by a vote of 12-5-0 (yay: Arnold, Bogad, Chan, Dienstag, Faulkner, Garcia, Giordano, Green, Ho, Ong, Sapp, Tavarez; nay: Alicea, Aubin, Izquierdo, Lee, Sheppard). There were no recusals.

Election of Vice Chairperson

Panel Member Dienstag nominated Dr. Angela Green as Vice Chairperson. Panel Member Garcia seconded the nomination. Jessamyn Lee nominated Thomas Sheppard as Vice Chairperson. Panel Member Alicea seconded the nomination. Dr. Angela Green was elected Vice Chairperson by a vote of

Motion to Adopt Meeting Minutes from May 22 Meeting

Motion to Postpone Chancellor's Regulations A-755 and A-411

Panel Member Sheppard made a motion to Postpone the consideration of Chancellor's Regulations A-755 and A-411 to the September meeting of the Panel for Educational Policy. Panel Member Lee seconded the motion. Motion defeated 2-14-0 (yay: Lee, Sheppard; nay: Alicea, Aubin, Bogad, Chan, Dienstag, Faulkner, Garcia, Giordano, Green, Ho, Izquierdo, Ong, Sapp, Sze-Tsang, Tavarez). There were no recusals.

Motion to Approve Chancellor's Regulations A-755 and A-411

Panel Member Giordano made a motion to approve Chancellor's Regulations A-755 and A-411. Panel Member Aubin seconded the motion. Motion approved 15-0-1 (yay: Alicea, Aubin, Bogad, Chan, Dienstag, Faulkner, Garcia, Giordano, Green, Ho, Izquierdo, Lee, Ong, Sapp, Sze-Tsang, Tavarez; abstain: Sheppard). There were no recusals.
